

#### **OVERVIEW**





S&P and Moody's study the financial condition of an entity to ascertain its creditworthiness. The credit ratings reflect the rating agency's opinion of the holdings financial condition and histories. Securities with credit ratings of BBB- and above are considered investment grade.
