

## Innovator Premium Income 20 Barrier ETF - April (19-3941)

Notification of Source of Distributions Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the quarterly dividend payment of \$0.485531 per share payable on July 3, 2023, to shareholders of record on June 30, 2023, it is anticipated that 63% of such dividend will be a return of capital.
