Gene Munster is widely regarded as one of the top 10 tech analysts³ on Wall Street, particularly for his insights on Apple Inc. He had a successful track record as of 2015, his last full year on the Street, according to analyst-ranking firm TipRanks.

After 21 years at Piper Jaffray, he announced his departure in 2016 to launch a research-driven venture capital firm the following year that invests in companies at the frontier of technology. He and his team choose the stocks that comprise the Loup Frontier Tech Index. The Innovator Loup Frontier Tech ETF invests in the stocks in this index.

Gene's team has decades of collective sector experience as tech equity analysts, startup founders, venture capitalists, and risk managers.



- HUYA (HUYA) is a video game live-streaming service, one of the largest in China. It also airs live broadcasts of other genres, such as cooking.
- Baidu (BIDU) is the Google and Netflix of China. It has a 75% share of online search on all platforms and its majority-owned iQiyi is one of the country's top video streaming platforms.
- Affirm Holdings (AFRM) is a fintech installment payment service for shoppers that promises upfront transparency on total interest charged with no late payment or annual fees.
- ams AG (SIX: AMS) develops high-performance sensors and sensing solutions incorporated into autonomous vehicles, 3D face recognition systems, robotics, among others.
- AeroVironment (AVAV) is a robotics company that develops unmanned military and commercial aerial drones.
