Notification of Source of Distributions

Pursuant to Rule 19a-1 under the Investment Company Act of 1940

In connection with the quarterly dividend payment of \$0.5461 per share payable on January 2, 2024, to shareholders of record on December 29, 2023, it is anticipated that 65% of such dividend will be a return of capital.

The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes. As a result, shareholders should not use the information provided in this notice for tax reporting purposes.
